

Letter of Commitment and Permission to Use

Should my proposal be selected to enter the exhibition, I hereby give the competition organizers and/or anyone on their behalf and/or anyone holding the permission, to make an exclusive, irrevocable, unlimited use of the piece and all its components, including publishing, displaying, copying, duplicating, altering dimensions or format, making a derivative piece etc., whether it be on their own or by third parties, including for the purpose of displaying it in exhibitions which will be presented according to the discretion of the competition organizers and/or anyone on their behalf.
4. As long as I shall be eligible for reward or compensation for my participation in the competition as described in the terms and conditions it is hereby notified that it is inclusive and final, and I will not be compensated any further for my participation in the competition and/or the selection of my proposal as the winner and/or the permission to use the piece and/or any use the competition organizers may make and/or anyone on their behalf, or their permission of the piece.
5. I am aware that I shall have no option to grant any third party a permission to use or any other right to use the piece, in any way, without the consent of the competition organizers in writing and in advance.
6. I am aware that the competition organizers will state my name on my work by the standard extent and scale.
7. I do not and will not have any claim and/or demand and/or litigation against the competition organizers and/or anyone on their behalf about my participation in the competition, their use of the proposal, or lack thereof, and transferring the copyright in the proposal.
